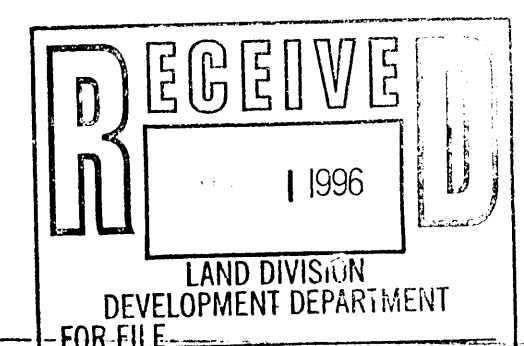
NOTES
