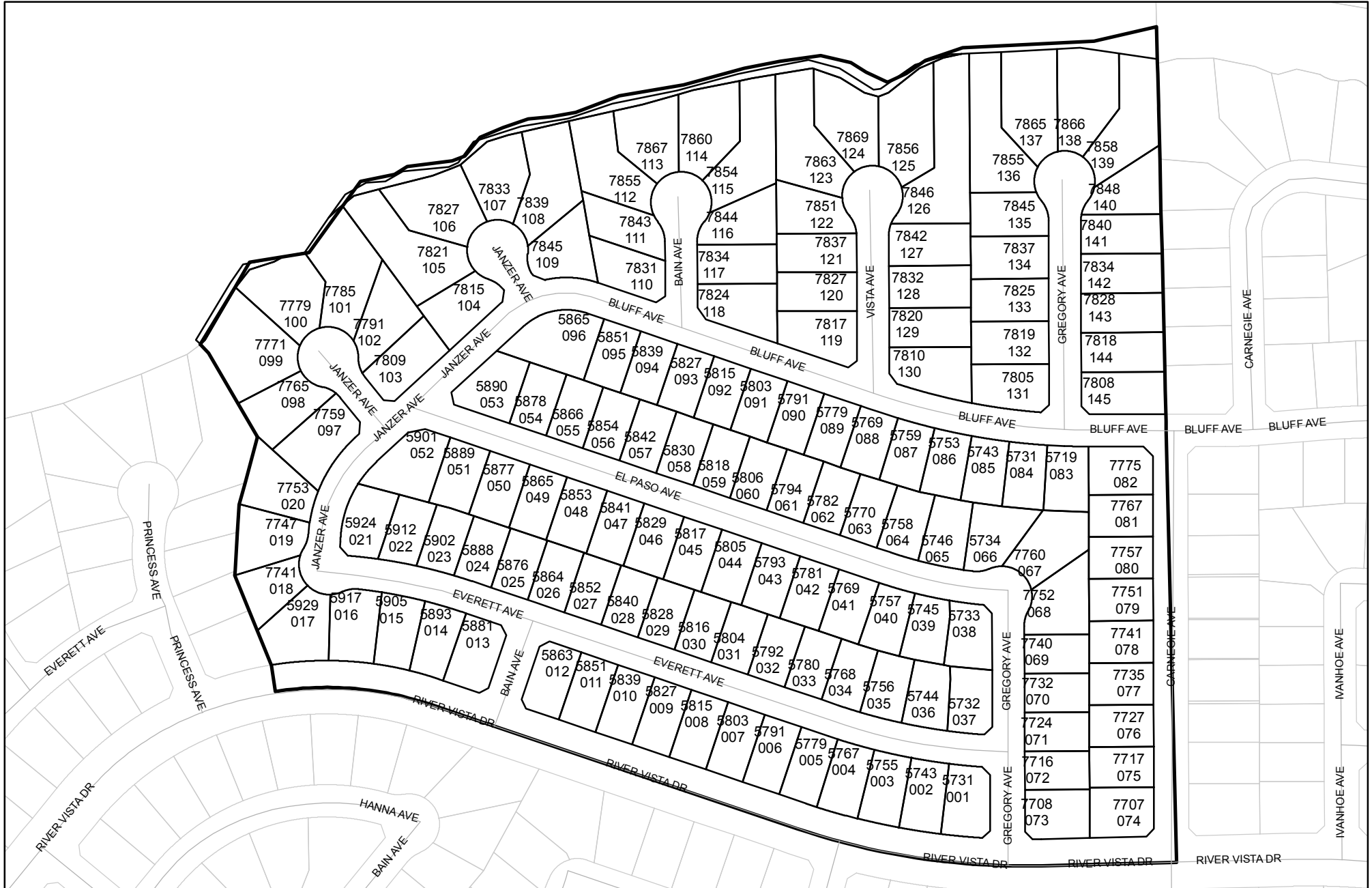

SET 3/4" X 30" IRON PIPE, DOWN 0.5', TAGGED LS 5277, OR WILL BE SET WITHIN ONE YEAR OR ANY APPROVED EXTENSION THEREOF, FOR ALL LOT CORNERS, BLOCK CORNERS, AND THE BEGINNING AND ENDING OF ALL CURVES.

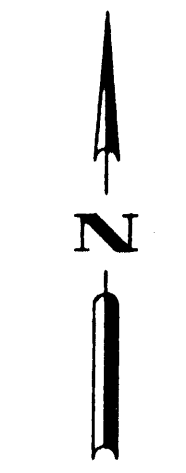

### BASIS OF BEARINGS

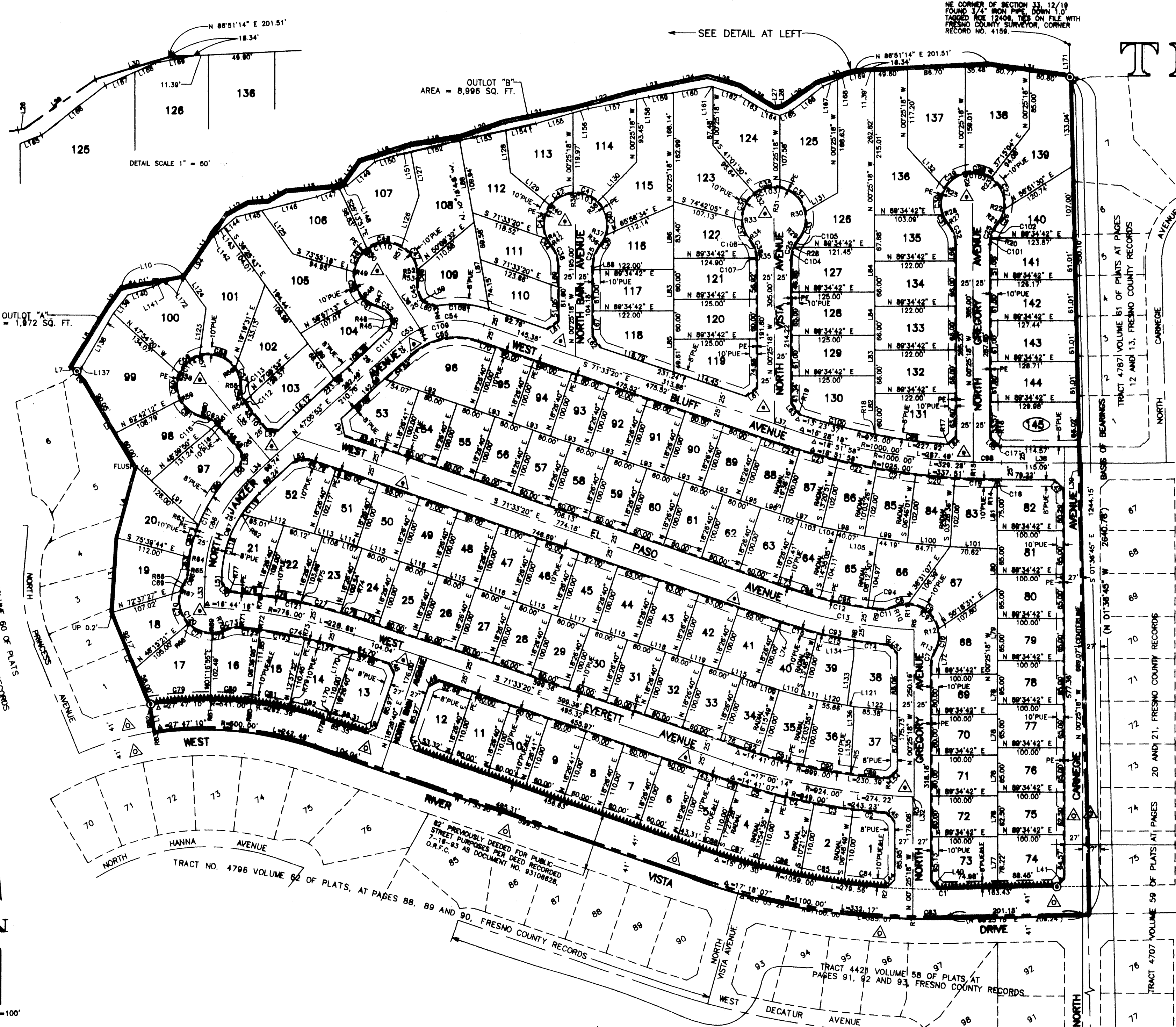
THE EAST LINE OF THE NORTHEAST QUARTER OF SECTION 33, 12/19, WAS TAKEN TO BE N 01°36'45" W, AS SHOWN ON PARCEL MAP NO. 98-03 ACCORDING TO THE MAP THEREOF RECORDED IN BOOK 57 OF PARCEL MAPS AT PAGES 21 AND 22, FRESNO COUNTY RECORDS.

OUTLOTS "A" AND "B" TO BE DEEDED TO THE CITY OF FRESNO FOR OPEN SPACE PURPOSES TO BE PRESERVED IN THEIR NATURAL STATE.

PREVIOUSLY DEEDED FOR PUBLIC STREET PURPOSES PER DEED RECORDED 7-28-95 AS DOCUMENT NO. 95008876, O.R.F.C.
