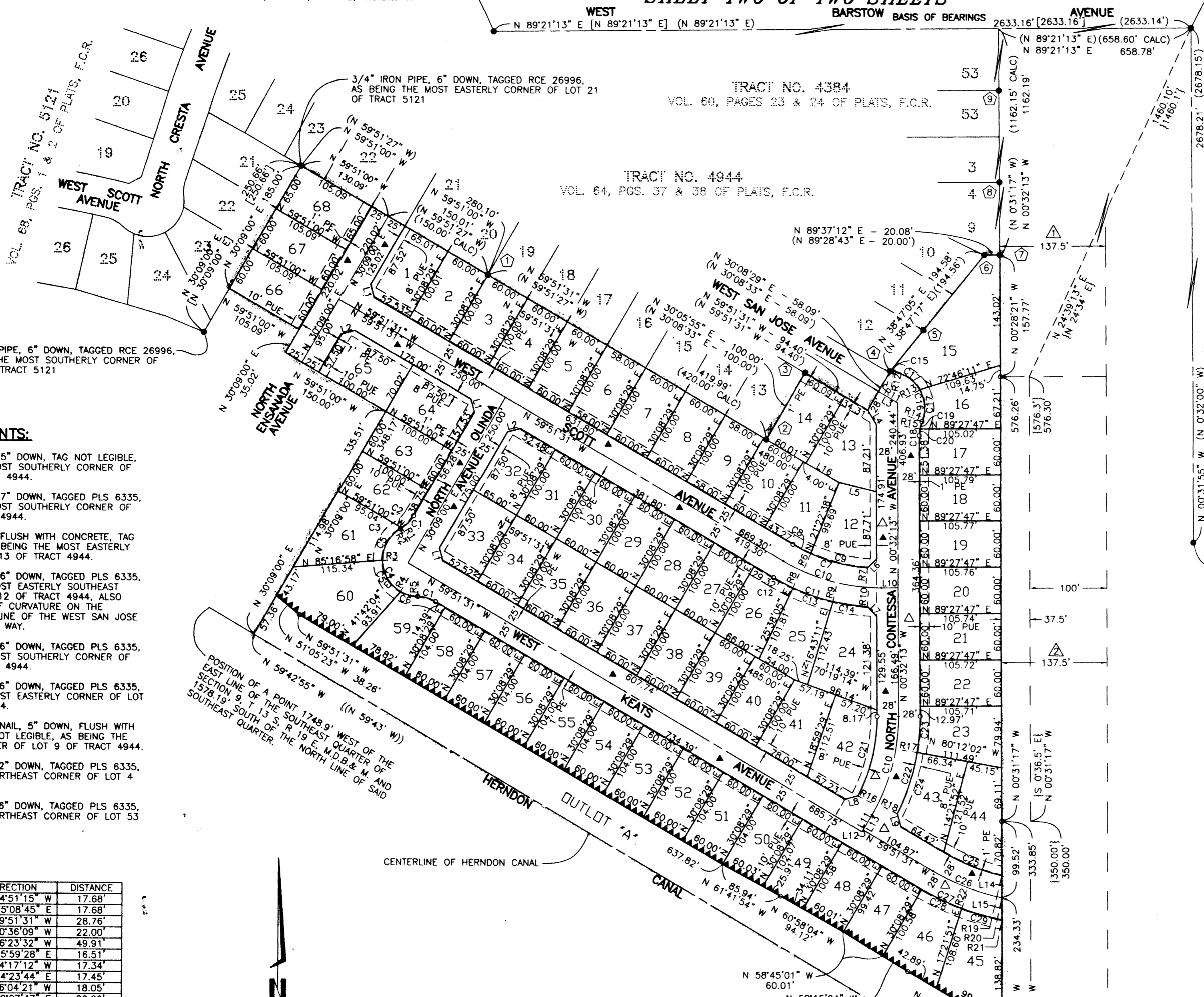

- ② 3/4" IRON PIPE, 7" DOWN, TAGGED PLS 6335, AS BEING THE MOST SOUTHERLY CORNER OF LOT 8 OF TRACT 4944.
- ③ 3/4" IRON PIPE, FLUSH WITH CONCRETE, TAG NOT LEGIBLE, AS BEING THE MOST EASTERLY CORNER OF LOT 13 OF TRACT 4944.
- ④ 3/4" IRON PIPE, 6" DOWN, TAGGED PLS 6335, AS BEING THE MOST EASTERLY SOUTHEAST CORNER OF LOT 12 OF TRACT 4944, ALSO BEING A POINT OF CURVATURE ON THE NORTHWESTERLY LINE OF THE WEST SAN JOSE AVENUE RIGHT OF WAY.
